 - (e) An audit report or any proof of advanced tax payment for the fiscal year: 2022-2023 (if applicable)
 - (f) An update CV of the visa applicant which includes a colour photo (2" x 1.5") taken within 6 months, educational background, working experience, permanent residence address abroad and address in Myanmar
 - (g) Assigned designation and duties of the foreign employee in the company Terms of Reference (TOR)
 - (h) Employment Contract and Proof of educational background of the applicant
 - (i) List of employees (Local / Foreigner) of the company including Names, Positions, Passport No., National Registration Card No., and Phone No.
 - (j) If the foreign employee is entering Myanmar for the second time, he/she must submit the proof of income tax payment for the previous term.
